About Snowmass Mountain: Base Elevation: 8,104 feet. Summit 12,510 feet. Skiable terrain: 3,362 acres. 94 trails, 21 chairlifts & 2 gondolas. Trails: Green: 53%, Blue: 21%, Black: 26%.
